## **5. Sponsorship Regulations**

A working group for Sponsorship Regulations (reference point 9.2 IISHF Working Meeting AGM 2022) need not be created as the 2020 Work Group on Media & Livestreaming Development has already drafted a version. Attached please find the proposal for final commenting to be done by each NMA until 31.05.2022. Thereafter the IISHF Presidium will enact the Sponsorship Regulations in accordance with §29.4 of the IISHF Regulations.

As discussed by the Council of Members during the IISHF Working Meeting on February 27.02.2022 IISHF is in need of Sponsorship & Advertising Regulations to define what advertising space can be offered to potential sponsors by the Hosts, the participating teams and the IISHF at/during the IISHF Title Events.

As communicated in the 2022-05 IISHF Communication Letter the 2020 IISHF Media & Livestreaming Development Work Group with its 22 representatives from 10 IISHF countries developed a first draft of these Regulations which had been reviewed and slightly amended by the IISHF Presidium, particularly regarding Chapter 1 “Definition, Purpose, Scope”.

The IISHF Presidium would like to ask all its NMAs to review these Regulations until 31.05.2022. Please send any comments or amendment suggestions to [office@iishf.com](mailto:office@iishf.com). They will be reviewed and discussed by the IISHF Presidium, which thereafter adopts a final version of these Sponsorship & Advertising Regulations.
